Housing Building 405 siding replacement

Project Description

This project addressed many environmental concerns related to suspected asbestos and lead based paint containing stucco on the main portion of this eight unit, two story, 15,000 square feet housing complex. Building 405 is located in the center of a very active and occupied housing area and is adjacent to a well-used playground facility as well as a Child Development Center. As such, extra care was taken to scaffold and fully contain the main building to ensure no suspected hazardous material of any type escaped the containment area. Previous testing of the stucco determined that the stucco contained actionable levels of asbestos and lead based paint which was to be removed and abated in accordance with California rules and regulations and federal law. More recent pre-construction testing indicated only low levels of lead-based paint and asbestos were actually present, however all proper protocols to include constant interior and exterior air monitoring was still performed out of an abundance of caution given the location of the building. The abatement phase of this project was completed in very short order and was completed without any safety or quality issues of any kind.

This project also included the removal and replacement of 74 windows, 40 doors/storm doors, and gutters and downspouts. New front enclosures were designed and constructed and the building was resided with pre-colored Hardie-plank cement siding. Other elements of work

included new telecommunication/data lines and a significant amount of concrete flatwork to include rear patios and a 250 linear feet access sidewalk.
